Meeting was called to order at 7:08 PM

- Vince Corsello, Vice President, introduced the board members and gave a description on the booster club duties.
- George Andrea, President, was not present at the meeting. Attempts have been made to contact George and have been unsuccessful. Vince Corsello was moved to the position of President and nominations were held for the open position of Vice President. Karen Muth nominated Gary Daniels. Brian Stover seconded the motion. The motion was passed; none opposed.
- Karen Reed reviewed the Treasurer's Report. Account balance is approx \$5100 with one outstanding check. The balance is ½ of last years balance due to last year's banquet expenses. Also, some bills were forwarded from the District going back three years. Coach Pye needs to obtain clarification on payment of these bills.
- 501c3 filing must be completed immediately. Discussed with Track Booster President, Randy Wright, and he agreed to allow the Cross Country Booster Club to combine the filing with the Track Booster Club. Half of the fees will need to be reimbursed to the Track Boosters. We will maintain our own bank account and file our own taxes. Brian Stover made a motion to combine the filing with the Track Booster Club. Dave Snyder seconded the motion. The motion was passes; none opposed.
- As discussed last meeting the voluntary spirit fees will be increased this year due to budget shortfalls. The \$110 voted on last meeting will not cover our expenses. Barbara Keifer made a motion to raise the spirit fees for to \$125 (one runner) and \$100 (addition family runner). Kris Zoetemelk seconded the motion. The motion was passes; none opposed.
- Volunteers were requested to assist Kris with the 7/10 Team Breakfast.

- Vince introduced the coaches. The coaches discussed the Sierra League and its members with possible changes coming in 2010. We have a large team this year with approximately 90 runners.
- All runners were requested to have good running shoes and watches.
- There will be no changes to the uniforms this year. Order forms will be available on the web-site next week and due by July 31st.
- Coach Staab requested parents to check the web-site daily for important team information. www.ayalacrosscountrytrack.org
- Mammoth Camp is August 15th-22nd. Thirty two athletes will be invited (16 boys, 16 girls, including some freshman). Invitations will go out the first week in August.
- The school/district will not be paying for buses this year. Coach Pye will advise if we will receive busses for the league meets. We may be assessed a transportation fee.
- 6th Period, Athletic PE has been approved for Cross Country this year.
- Fundraisers were discussed. We need to do some fundraising due to the shortfalls in the budget. Karen Reed will obtain information on eScript and give a recommendation. All fundraisers must be board approved.
- Spirit Wear will be pre-ordered only.
